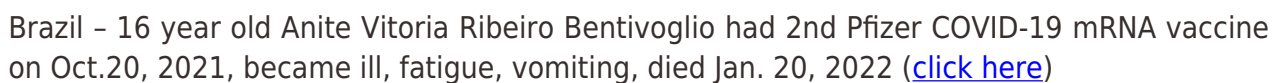

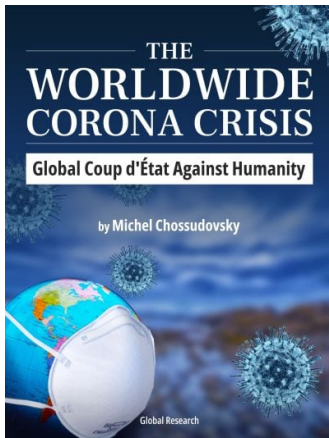
And that's very troubling, because we are now seeing the longer term adverse effects of COVID-19 mRNA vaccination that were never studied.
