*July 22, 2023 – Perth, Australia – 24 year old Krystal Pitt collapsed while lining up at a local post office just 10 days after giving birth to her 2nd child, and died in hospital a few days later ([click here](#)).*

A father has been left heartbroken after his wife died tragically just days after giving birth to their second child.

Brayden Yates' wife Krystal Pitt, 24, died 10 days after giving birth to her second child, Toby, just over a fortnight ago.

The couple had been lining up at the Noranda post office, in [Perth](#)'s northern suburbs, after visiting Toby in the neonatal intensive care unit in Perth Children's Hospital when Ms Pitt told Mr Yates her chest hurt.

Within seconds, he realised she was having a heart attack.

'I had her sit down and then pretty quick, she had a cardiac event,' Mr Yates, 28, told the [West Australian](#).

Mr Yates called triple-0 before performing CPR and then setting up a defibrillator in a desperate attempt to save his wife's life before an ambulance arrived.

Ms Pitt was then placed into an induced coma and while her prognosis was initially positive, her health quickly deteriorated before she died in hospital on Saturday.

It is understood Ms Pitt, who had a pre-existing blood condition, **died from blood clots that had formed in her lungs and triggered the cardiac arrest.**

The couple, who are originally from York, had named their son Toby together at the hospital before she passed away.

Translation:

- Krystal is presumed to have been COVID-19 vaccinated.
- She went into premature labor and had a baby 4 weeks before due date (first red flag – vaccinated women have a higher risk of going into premature labor)
- She then developed pulmonary embolism (blood clots in her lungs) which caused her cardiac arrest 10 days after delivery (second red flag – too many vaccinated women are developing blood clots after delivery)
- In the hospital, she was put on blood thinners and placed into an induced coma (third red flag – the cardiac arrest appears to have been unusually severe)
- During her hospital stay, “while her prognosis was initially positive, her health quickly deteriorated before she died in hospital...from blood clots that had formed in her lungs and triggered the cardiac arrest” (fourth red flag – the blood thinners doctors were treating her with didn’t work and she died from the blood clots in the lungs – vaccinated patients have treatment resistant blood clots).

Another news story confirms that doctors were trying to stabilize her and treat her blood clots but were unsuccessful ([click here](#)).

Once Pitt was on the ground, Yates performed CPR and a public defibrillator was set up before emergency services arrived stabilising Pitt and safely transporting her to hospital.

Yates said once his wife had been assessed in the hospital, she was placed into an induced coma with doctors optimistic she would survive the terrifying ordeal, however, things quickly took a devastating turn.

Pitt, who had a pre-existing blood condition, **began deteriorating in hospital with doctors unable to stabilise her** and she sadly passed away after blood clots formed in her lungs - which was also the trigger of her cardiac arrest.

Speaking to the Australian news outlet, a grieving Yates said despite his family’s loss, he is “grateful” that he and his late wife were able to name their four-week premature son together.

As well as their young son - who is reportedly doing well and set to be released from the hospital soon - Pitt is also survived by their 14-month-old daughter.

# Perth woman Monika Mann dies days after giving birth to twins at Fiona Stanley Hospital, review demanded

The death of a Perth mother days after giving birth to twins in hospital should be subject to an independent, external review, a health advocate says.

Monika Mann, 36, died on May 15, seven days after giving birth to a little girl and boy at Fiona Stanley Hospital, in Perth's south.

She was discharged from hospital six days after the birth but returned the following morning and arrived at the Emergency Department "unresponsive" and was declared dead shortly after.

## Key points:

- Monika Mann died seven days after giving birth to twins at Fiona Stanley Hospital
- She was discharged six days post delivery, but returned with abdominal pain the next day
- Ms Mann had existing health issues, including heart disease and a mechanical heart valve

## Tori Bowie, an elite Olympic athlete, died of complications from childbirth

Tori Bowie, who captured gold as a sprinter in the Olympics and the world championships, died at age 32 from complications of childbirth, according to an autopsy report.

She was once the fastest woman in the world. So when Tori Bowie was found dead last month at just 32 years old, it rocked the sport of track and field. And now the tragedy of her death is fully known: Bowie was eight months pregnant, and died due to complications from childbirth.

The revelation came from the Orange County Medical Examiner's Office in Florida, which just released its autopsy report on Bowie. The report concludes that Bowie, who was found in bed alone in a home, had been undergoing labor.

Bowie, whose career highlights include a 100-meter world championship and three Olympic medals (one of them gold), was found deceased on May 2, during a welfare check. The local sheriff's office had sent deputies to check on her after she wasn't seen for several days.

### Natural causes are cited in autopsy report

The elite athlete died from natural causes, Associate Medical Examiner Chantel Njiwaji wrote in her autopsy report, citing evidence of Bowie undergoing labor when she died. The toxicology report came back negative.

Njiwaji cited possible complications from respiratory distress and eclampsia. Eclampsia, like preeclampsia, is a disorder related to high blood pressure during pregnancy. The dangers of the two conditions are well-documented, even if their precise causes aren't yet known.

## Prime Healthcare hospital under investigation after death of new mother

A Los Angeles area hospital operated by Ontario, Calif.-based Prime Healthcare is under investigation after the death of a woman in its care amid allegations of neglect, according to a March 3 report in *The Guardian*.



April Valentine, a 31-year-old Black woman who was pregnant with her first child, went to Centinela Hospital Medical Center in Inglewood, Calif., Jan. 9 and died the next day, the article said. Her family and friends claim the hospital ignored the patient's complaints of pain, neglecting her as her boyfriend performed CPR on Ms. Valentine after the emergency cesarean birth of their daughter, Aniya.

Now the hospital is under investigation from California's department of health and human services to determine if it violated any regulations. The hospital could face fines and the potential suspension or revocation of its license as a result of any evidence staff failed to properly care for Ms. Valentine.

A Pennsylvania woman who died shortly after giving birth is being remembered for her passion as both a mom and a teacher.

Jennifer Krasna, 30, of Newtown, died Monday only [days after giving birth](#) to her second son, Cade, according to ABC affiliate WPVI-TV.

The Bucks County woman, who was a teacher at Charlestown Elementary School in Malvern, passed away "[unexpectedly](#)," Principal Chris Pickell told FOX affiliate WTXF-TV.

Jennifer's husband Jesse Krasna [paid tribute](#) to his "amazing wife" in a post shared Tuesday on Facebook. He said "nothing got in the way of her being the best mom she could be."

Oct. 24, 2022 – Texas – 29 year old Krystina Pacheco suffered septic shock. Two days after giving birth to a girl, she developed shortness of breath, vomiting, stomach pains, was hospitalized with septic shock. Sedated for 2 weeks she nearly died and had to have her hands and feet amputated ([click here](#)).



Feb. 1, 2022 - UK - 41 year old Amber Pendlebury delivered a baby boy, then cried out "I can't breathe", had two cardiac arrests and died shortly after ([click here](#)).

The devastated family of a woman who died shortly after giving birth have shared a heartbreaking image of her last moments of life.

Amber Pendlebury suffered a fatal heart attack after her baby boy Maxwell Lee was born under general anaesthetic

The 41-year-old was placed on life-support as soon as she woke up after taking two rapid cardiac arrests but tragically she could not be saved.

The former sales manager said that, days before her death, Amber had been very positive about her pregnancy and had "prepared everything" for the arrival of her third child.

But just after tiny Maxwell Lee was born, Amber cried out "I can't breathe" and collapsed, before medics frantically whisked her away for emergency treatment.

Amber passed away on February 1, with her grief-stricken mother still shocked at the nature and speed of her unfortunate death.

"She was supposed to go in for a c-section in the morning, and when she got there, she decided she wanted to do a natural birth.

"So they induced her, but she'd been on the drip for the inducement for at least ten hours, and she was only 4cm dilated, which is not good. They later said they'd have to do a caesarian section, but said they'd have to put her to sleep while they did it."

Doctors were bringing the mum round when she had a series of sudden heart attacks and never caught a glimpse of her baby before she collapsed.

Vida added: "Doctors delivered the little baby, who was 6 pounds, 2 ounces. But she never saw him, as when she woke up, she said, 'I can't breathe, I can't breathe! My chest is on fire, my chest is on fire!'"

"That's all her partner heard her say, and then she was whisked away."

On January 26, the family received the news that Amber was on a life support machine.

A Florida woman's heartbroken family is grieving her death from Covid-19 just days after she gave birth to her daughter via emergency cesarean section.

The woman, Kristen McMullen, 30, was hospitalized with the virus July 21, her aunt Melissa Syverson said Thursday. She was also diagnosed with pneumonia and sent home after four days, but she was hospitalized again on July 26.

She delivered her daughter, Summer Reign, by emergency C-section July 27 and was transferred to the intensive care unit. McMullen was placed on a ventilator last Friday and died the same day, her family said.

"That first week, honestly, Kristen's main concern was Summer and just making sure that she was OK," Syverson said.

Summer is healthy and "definitely bringing joy" to the family, who are struggling to cope with their loss, Syverson said.

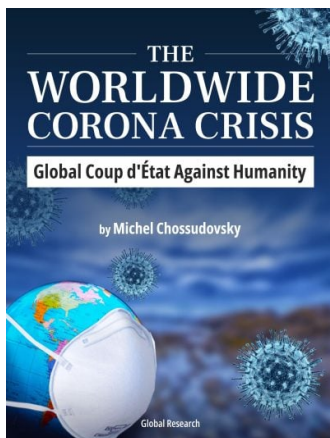
