

Dear Family, friends and community,

As many of you know, our sister-in-law Tracy was diagnosed with breast cancer last year and underwent surgery and months long treatment. She has been on the road to a full recovery, but it has been difficult and emotionally overwhelming for the family. Then this spring, our brother Billy was diagnosed with tonsil/neck/throat cancer. In February 2023 he had surgery on his nose for post nasal drip and other issues, and when he found a lump on his neck a few weeks later, the doctors thought it was an infection related to the surgery. He was put on a round of antibiotics with no result. They scheduled a series of tests and xrays/scans and discovered nodules/tumors in his neck, and on one of his tonsils; CANCER. The word no one wants to hear.....

He is now in the midst of daily treatment; chemotherapy and intensive radiation on his neck and throat. He is not able to eat or drink and had a feeding tube placed at the start of treatment to sustain him. There will most likely come a time when the pain will be so intense he will not be able to speak. The hope is he will regain his ability to swallow, eat and speak with the understanding his voice could be different, his taste buds could be destroyed, chronic dry mouth...the list goes on.

He has speech therapists, nutritionists, radiologists, oncologists, nurses, VNA all at a cost. His insurance covers only a portion of the staggering amounts of money needed to treat this deadly disease. This has taken a toll on both Billy and Tracy, as they attempt to maintain their household and their jobs, all while making daily trips back and forth to Dana Farber.

Just breathe. Deeply. See you on the other side.


Final tests happened. At 12:10 Jill went to be with Craig.




Our MSG Networks family has suffered a tremendous loss.

Our thoughts and prayers are with his family.





Andrew (11) in ICU with severe myocarditis



Hi! We are raising funds for the Amber family. They are involved in church planting in Muslim majority countries and were visiting FL to tell churches here about their ministry when their 11 year old son (Andrew) suddenly became ill. They were taking pictures near the beach when Andrew started coughing. By the time they arrived at their hotel, he felt worse and had low oxygen saturations. They went to a hospital nearby (Sarasota Memorial), and he ended up being intubated for worsening breathing problems before being transferred to All Children's Hospital in St. Pete. He was intubated for several days before starting to improve, but last night he developed an abnormal heart rhythm and coded. The team at the hospital was able to rescusitate him, but he has a long road ahead. He has myocarditis (inflammation of the heart muscle) likely caused by a viral infection.



Because of your kindness, my family did not have to worry about food for a while. I am thankful to all that are still supporting financially. Your help is helping us with so many bills. I am thankful to our dear neighbors for stepping in to take care of us. Lastly and most importantly, I am thankful for all that are still praying. I am still on a road to recovery. 

Darrick has been the breadwinner of our family for the last 20 years as a doctor caring for others. He has been working in the urgent care field the last 5 years. Here in Texas he works at a privately owned small doctors urgent care. Unfortunately because it is small, there is no PTO or Disability. Since Covid, the days at urgent care are long and unbelievably busy. The average day there would be 100 patients to be seen. The vaccine is possibly the cause for these medically unexplained strokes.

He is unable to speak, but is able to write things on the board. We are encouraged that he can make a full recovery but the doctors say it can take up to a year.
