Rep. <u>Matt Gaetz</u> of Florida has joined a small number of House Democrats on a measure to block President Biden from sending cluster bombs to <u>Ukraine</u>.

The bipartisan measure is an amendment to the National Defense Authorization Act and is one of more than 1,500 add-ons tacked on to the bill since the House Armed Services Committee passed it last month.

The House is expected to consider the NDAA this week after the House Rules Committee pares down the massive list of amendments on Tuesday.

Mr. <u>Gaetz</u> announced Monday on his podcast, "Firebrand with <u>Matt Gaetz</u>," that he would be the Republican co-sponsor on the amendment.

"These cluster bombs will not end the war in <u>Ukraine</u> and will not build a more stable country," Mr. <u>Gaetz</u> said on social media. "Children will be left without limbs and without parents because of this decision if we do not work together in a bipartisan fashion to stop it."
