Nuclear expert Arnie Gundersen said today that <u>the containment vessel at Fukushima</u> reactor 2 has a large crack in it.

Reactors <u>1, 2 and 3</u> all exploded.

BBC reports today:

They know very little about what's going on inside Reactors 1, 2, and 3 [...]

They don't really know what the state of the reactor core is.

Indeed, there is no containment at Fukushima.

The operator of the Fukushima plants says it's <u>"impossible" to keep storing radioactive</u> water in tanks, and Tepco will need to *intentionally* dump it into the ocean.

And Tokyo is <u>almost as irradiated as Fukushima</u>.

Agence France-Presse notes:

Beach walkers are likely to encounter a disturbing but relentless flow of flotsam [from Japan] for years to come.

American sailors were <u>exposed to massive doses of radiation</u>. Conditions were so bad that they <u>considered suicide</u>. Many of these good men and women are now really sick. More <u>here</u>, <u>here</u> and <u>here</u>. (But both the Japanese and American governments have <u>abandoned</u> <u>them</u>.)

Tepco might not even meaningfully start working to decommission the plants until the radiation level drops ... <u>decades from now</u> (Or until the <u>technology exists</u> to clean it up.)

It has now been <u>officially admitted</u> that the accident was caused by <u>collusion between the</u> <u>government and nuclear industry</u>.

A worker at the Fukushima nuclear plan succinctly notes:

Even an elementary-school kid knows TEPCO always lies.

We don't mean to pick on Japan. After all, <u>the American government is dictating nuclear</u> <u>policy in Japan</u>. American reactors are even <u>more dangerous than Fukushima</u>. And a secret report confirms that Southern California Edison <u>knew of major problems at the San Onofre</u> <u>nuclear plant</u> ... but let the slipshod expansion and remodeling project continue anyway.
