

## Secretive Agendas behind Closed Doors: World Bank Whistleblower Writes to Bilderberg

Karen Hudes worked in the World Bank legal department for more than 20 years and held the position of Senior Counsel. She was fired or blowing the whistle on corruption inside the World Bank.
