Write-up: died in his sleep 3 days after taking the Pfizer covid vaccine; This is a spontaneous report from a contactable consumer. A 13-years-old male patient received the second dose of BNT162B2 (PFIZER-BIONTECH COVID-19 VACCINE) via an unspecified route of administration on an unspecified date (Batch/Lot number was not reported) as dose 2, single for covid-19 immunisation. The patient's medical history and concomitant medications were not reported. Historical Vaccine included the first dose of BNT162B2 (PFIZER-BIONTECH COVID-19 VACCINE) for COVID-19 immunisation. The patient experienced died in his sleep, 3 days after taking Pfizer COVID vaccine on 16Jun2021. This is coincidental, this is not causative. Cause of death was unknown. No investigation assessment. The patient died on 16Jun2021. The county health department confirmed the investigation and the autopsy was being performed. The information is being sent the CDC to see if there is a correlation. The reporter mentions that we all know a lot of 13-year-old falling over for that. Information on the lot/batch number has been requested.; Reported Cause(s) of Death: Cause of death was unknown

Notice that even though the age is known, the Age box is deliberately left blank. The date of vaccination is also known but was also left blank. This boy died in his sleep 3 days after taking Pfizer vaccine. As a parent, I'd want to know about this.

Write-up: Completed suicide; Malaise/feel generally unwell; Nasal congestion/book nose; This is a spontaneous report received from a contactable reporter (Physician) from Regulatory Authority. Regulatory number: AEFI-A-050821 Case Number A 17-year-old male patient received bnt162b2 (COMIRNATY) administration date 26Oct2021 (Lot number: unknown) as dose 2, single for covid-19 immunisation. The patient's relevant medical history and concomitant medications were not reported. Vaccination history included: Covid-19 vaccine (dose 1, manufacturer unknown), for covid-19 immunisation. The following information was reported: COMPLETED SUICIDE (death, medically significant) with onset 28Oct2021, outcome "fatal", described as "Completed suicide"; MALAISE (non-serious) with onset 27Oct2021 07:00, outcome "unknown", described as "Malaise/feel generally unwell"; NASAL CONGESTION (non-serious) with onset 27Oct2021 07:00, outcome "unknown", described as "Nasal congestion/book nose". Patient was now deceased. Report done as requested by his mother. Once again, the age box is left empty, although it is known the boy is 17 years old.

Imagine parents who are concerned whether COVID-19 vaccines will impact the mental health of their children. This tragic case could have affected their decision to vaccinate their child. But this death is hidden, it does not come up in any search.

Write-up: Found dead at 01 o'clock at night without prior symptoms of any kind. This is a spontaneous report received from contactable reporter(s) (Consumer or other non HCP and Physician) from the regulatory authority. Regulatory number: DK-DKMA-ADR 26295617 (DKMA). A 12 year-old male patient received bnt162b2 (COMIRNATY) administration date 27Nov2021 (Lot number: FF0884) as dose 1, single for covid-19 immunisation. The patient's relevant medical history and concomitant medications were not reported. The following information was reported: DEATH (death, medically significant) with onset 01Dec2021, outcome "fatal", described as "Found dead at 01 o'clock at night without prior symptoms of any kind". The patient date of death was 01Dec2021. The reported cause of death was "Found dead at 01 o'clock at night without prior symptoms of any kind". The autopsy was performed, and results were not provided. Clinical course: On 01Dec2021, 4 days after vaccination, he was found dead at 01 o'clock at night without prior symptoms of any kind. The patient had been happy and playing computer games online with his friends until he went to bed at 23:00 on 30Nov2021. Reported cause of death was not reported. An autopsy had been performed but the result was not expected to be available until 3 months. The ADR was by the reporter reported as being Fatal. There was no information regarding test results. Causality: The relative reports as the child has been vaccinated 4 days earlier and he therefore believes it should be reported. Once again, age is known but not entered where it should be. This was the saddest line in the report: "patient had been happy and playing computer games online with his friends until he went to bed at 23:00 on 30Nov2021. Found dead at 01 o'clock at night without prior symptoms of any kind"

This is baby case created from the mother's case received from the Medicines Healthcare products Regulatory Agency (MHRA). This is the baby report. Only this case is serious. A fetus patient of unspecified gender received BNT162B2 (PFIZER-BIONTECH) COVID-19 VACCINE, batch/lot number: EK4244, transplacental on 04Feb2021 at single dose for covid-19 immunization. The mother's medical history was not reported. The mother's concomitant medication included folic acid as folic acid supplementation. The patient's mother received BNT162B2 on 04Feb2021. The patient's mother was exposed to the medicine. Second-trimester (13-28 weeks) The patient's mother had premature labor. Live infant delivered but passed away on 10Feb2021. The baby was alive when it was born. The age of the infant is 0, but instead, it's left blank. Safe for pregnancy? It seems that "premature labor and a dead baby" is not exactly the definition of "safe".

Write-up: A woman in week 40 of pregnancy was vaccinated and the next day the fetus died. This is a spontaneous report from a contactable physician who reported similar events for two patients. This is the second of two reports. A pregnant female patient (in week 40 of pregnancy) received BNT162B2 (PFIZER-BIONTECH COVID-19 VACCINE, solution for injection), via an unspecified route of administration on an unspecified date at single dose for covid-19 immunisation. The patient medical history and concomitant medications were not reported. The patient was vaccinated and the next day the fetus died on an unspecified date. The reporter did not think there was a connection but due to the proximity to the vaccine she reported. Information about batch/lot number has been requested.; Sender's Comments: Limited information precludes a medically meaningful assessment of the case. Based on the current available information and in agreement with reporter's assessment, the event is unlikely related to the suspected drug of BNT162B2. The case will be reassessed if additional information becomes available.; Linked Report(s) : IL-PFIZER INC-2021208688 same reporter/vaccine/event different patient; Reported Cause(s) of Death: Fetal death

Nothing says "safe in pregnancy" like a pregnant woman at 40 weeks taking a Pfizer mRNA jab and having her baby die the next day. No age entered for the stillborn baby. Even "fetal death" is spelled wrong to make sure this case doesn't show up in any search.

Concomitant medication included ergocalciferol (VIT D), folic acid (FOLATE), ascorbic acid/betacarotene/calcium sulfate/colecalciferol/cyanocobalamin/ferrous fumarate/folic acid/nicotinamide/pyridoxine hydrochloride/retinol acetate/riboflavin/thiamine mononitrate/tocopheryl acetate/zinc oxide (PRENATAL VITAMINS) and sertraline hydrochloride (ZOLOFT) at 25 mg, all transplacental. It was reported that OB exam on 03Feb21 showed healthy baby at 7weeks 5days, heartbeat detected 152 bpm; no abnormalities identified via ultrasound; labs and hormone levels all within normal ranges. Per ultrasound on 20Feb21, fetus stopped growing on 09Feb21 (8w4d); no heartbeat detected. Miscarriage occurred 22Feb21.

There are several of these cases. Mother has a healthy baby at 7wk 5d on Feb.3, 2021. She takes a Pfizer mRNA jab on Feb.4, 2021. Her next ultrasound shows that the fetus stopped growing on Feb.9, 2021 and "no heartbeat detected". Miscarriage occurred on Feb.22, 2021.

I can see why someone is illegally altering VAERS reports to hide these tragic deaths.

This 13 year old boy died a horrific death only 11 days after his Pfizer jab: "Blood coming from his nose, frothing at the mouth, tongue was blocking his airway".

The reported cause of death was "myocarditis".

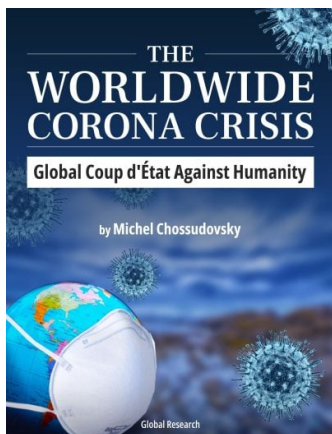
