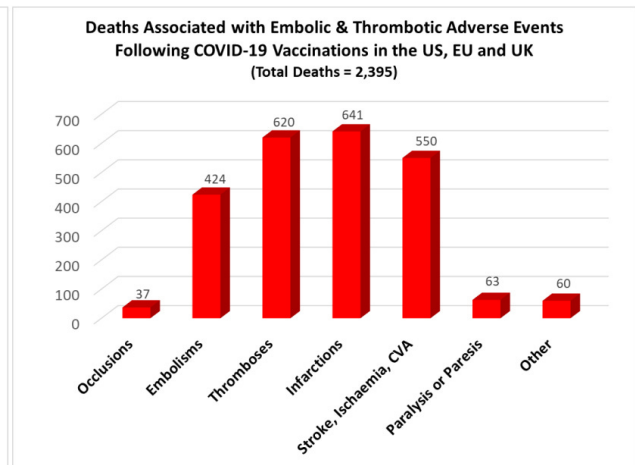
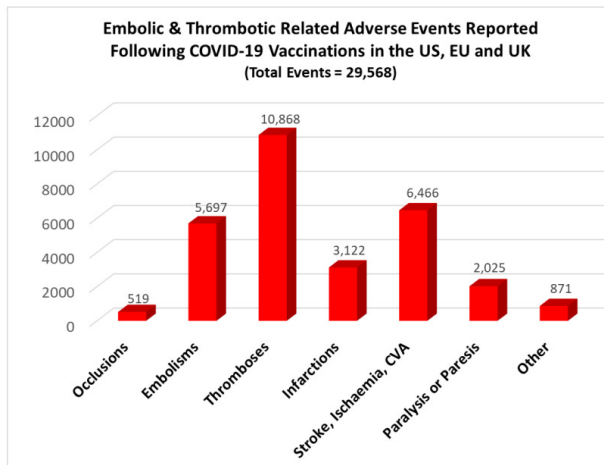
## All COVID-19 vaccines cause blood clots

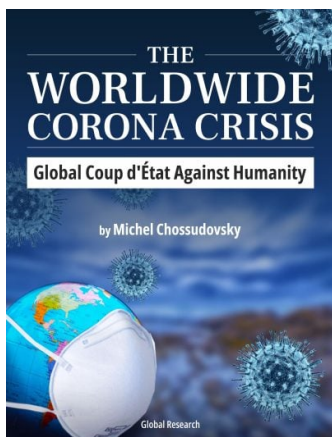
